WorkWISE NH provides a free on-site Occupational Safety & Health Consultation Service to eligible employers. Although the Consultation Service is primarily targeted to small businesses, the program welcomes the opportunity to assist employers of any size. Whether an employer has a question about the safe use of a specific piece of equipment or would like information about establishing a workplace safety program at a work site, program staff is available to provide consultation to employers seeking such assistance.

To be eligible for the Consultation Service businesses must:

- be located in NH; and
- be privately owned;
- have 250 or fewer employees at one site and fewer than 500 employees in total.

Loans range from \$1,000 to \$500,000 for existing businesses (business must have revenue for past 12 months and paid taxes).
